WATER RESOURCES ACT 1991

THE RIVER USK ROD AND LINE (SALMON AND SEA TROUT) BYELAWS 2021

The Natural Resources Body for Wales in exercise of its powers under section 210 of, and paragraph 6(1)(b) and 6(2)(a) of Schedule 25 to, the Water Resources Act 1991 makes the following byelaws.

Byelaw 1 - Title

These Byelaws may be cited as the River Usk Rod and Line (Salmon and Sea Trout) Byelaws 2021.

Byelaw 2 - Application

These byelaws shall be read in conjunction with the Rod and Line Byelaws 1995 as amended and the Wales Rod and Line (Salmon and Sea Trout) Byelaws 2017.

These Byelaws will cease to have effect on the 31st December 2029.

Byelaw 3 - Interpretation

In these Byelaws unless the context otherwise requires

- (a) "Natural Resources Wales" means the Natural Resources Body for Wales.
- (b) "River Usk" means the whole of the River Usk and its tributaries.
- (c) "Salmon" means salmon of the species Salmo salar and includes part of a salmon;
 - "sea trout" means any fish of the salmon family commonly known as sea trout or sewin, (migratory trout) and also includes part of a sea trout.
- (d) "the Rod and Line Byelaws 1995" means the Byelaws regulating fishing by means of

rod & line and making certain general provisions relating to fishery matters made by

the National Rivers Authority Welsh Region.

(e) Except as provided above or where the context otherwise requires all words and

expressions used in these Byelaws shall have the meanings assigned to them by the

Salmon and Freshwater Fisheries Act 1975, the Water Resources Act 1991 and

Environment Act 1995 or any statutory modifications or re-enactment thereof.

Byelaw 4 - Catch and release with rod and line (salmon)

(a) Subject to the provisions contained within existing fisheries byelaws affecting the

River Usk, any person who removes any live or dead salmon taken by rod and line

in the River Usk without the previous written authority of Natural Resources Wales

shall be guilty of an offence.

(b) This byelaw shall not apply to any person who lawfully takes a salmon and returns it

immediately to the water with the least possible injury.

Byelaw 5 - Catch and release with rod and line (sea trout)

(a) Any person who before the 1st May removes any live or dead sea trout taken by rod

and line in the River Usk without the previous written authority of Natural Resources

Wales shall be guilty of an offence.

(b) This byelaw shall not apply to any person who lawfully takes a sea trout and returns

it immediately to the water with the least possible injury.
